



Terms and Conditions

- 1) This contract is between 4D Baby and you the customer, and shall be governed by the following terms and conditions of trade. Nothing in these conditions will affect your statutory rights.
- 2) 4D Baby provides non-medical, non-diagnostic 2d-3d-4d foetal ultrasound scanning services.
- 3) 4D Baby offers you the 4D ultrasound scan on the understanding that you are receiving the appropriate ante-natal care and have had 2 normal hospital scans. If attending for a Sexing scan you will have had a 12 week hospital scan.
- 4) Under no circumstances should your 4D Baby scan be a substitute for your hospital ultrasound scans. Please note our sonographer is not in the position to offer medical or diagnostic advice.
- 5) We recommend that you have your 4D Baby scan after 24 weeks, following your 20 week hospital scan. Your 4D scan is dependent on the positioning of baby at the time of your scan, if for any reason we are unable to provide clear images of your baby we will welcome you back for a re-scan at no extra charge. This will be at the sonographers discretion on the day. Please note we cannot offer re-scans on Wowcher or Groupon deals as per their terms & conditions.
- 6) Any problems found at the time of your scan will be explained as fully as possible with the recommendation that your ante-natal provider be informed as soon as possible. Please note **WE DO NOT LOOK FOR ABNORMALITIES** and cannot be held responsible for any found at a later date. By signing this form you are giving your consent for us to notify your ante-natal provider.
- 7) If attending for a sexing scan the sonographer will endeavour to determine your baby's gender. Although we give you an indication of your baby's sex this **cannot be guaranteed**. It is not always possible to ascertain the sex of your baby.
- 8) Your 4d scan will be recorded onto DVD (un-edited)and CD-ROM, this is included in the price. Please note we do not keep copies of your scan and we cannot retain any images. If you require copies of the CD-ROM please request at the time of scan. Copies are available at £10 each.
- 9) The ultrasound scan, DVD and CD-ROM are to be used as a pictorial keep-sake souvenir of your unborn baby and cannot be used for any type of medical or legal reason other than home entertainment.
- 10) The price for a 4D Baby ultrasound scan shall be that illustrated on our website. 4D Baby is not bound to deliver your scan, DVD or pictures until fully paid for. A non refundable £25 deposit is required when booking to secure your appointment. The outstanding balance will be payable on the day of your scan.
- 11) We accept all major debit and credit cards, however a 3% surcharge will be levied on all credit cards to cover the banking fees associated with credit cards.
- 12) 4D Baby accept no responsibility for any loss or damage to any personal effects howsoever caused while you the customers are on our premises.
- 13) 4D Baby shall not be responsible for any loss or damage caused by any act or omission by 4D Baby employees, servants or agents. Save for death or personal injury unless set out in these terms and conditions.
- 14) 4D Baby will not be held responsible for any breach of this contract caused by circumstances beyond its reasonable control.
- 15) This contract is governed by the laws of England and Wales and is the entire contract between you and 4D Baby.
